# Millbrae Art & Wine Festival - September 5th & 6th, 2020

## Food Concession Instructions

Please make a copy of your application and instructions for your records.



**Day of Event:** The Concessionaire is responsible for the set-up and strike of the concession booth and all materials needed for its operation. If the Chamber of Commerce is providing a booth, it will be set up and removed for you. The concessioner is responsible to remain within the assigned booth space only. There will be no exceptions. If concessioner does not follow rules (i.e. spills or items on sidewalk area) this will result in loss of Security/Cleaning Deposit.

**Selection:** Space will be restricted to 10' x 10' increments and are located in 3 areas evenly spaced on Broadway. A separate space is required for a BBQ or open flame grills for an additional fee. The spaces are up against the curbside, facing the center of the street. The sidewalks are open to the public. Concessionaires are prohibited to use sidewalks as storage or cooking space. Non-compliance will result in loss of Cleaning Deposit.

**Food Vendor Accounting Form:** All concessionaires are required to complete a Food Vendor Accounting Form at the conclusion of the Festival. The form and any payment due must be returned to the Millbrae Chamber of Commerce within 10 days after the Festival. The amount due is 15% of your Gross, booth fees are not to be deducted.

**Security/Cleaning Deposit:** Refundable only after the Food Vendor Accounting Form and payment is submitted to the Millbrae Chamber, and only if food vendor was in compliance with all instructions.

**Beverages:** Only Non-Alcoholic beverages may be sold. Sale of Sodas is now permitted. **No Water!**

**Fire Extinguishers:** All concessions will require fire extinguisher within reach in the booth. This will be verified by the Millbrae Fire Department before you are allowed to open for business. The required extinguisher should be a 2A:20 BC or larger.

**Power:** There is limited electrical available to concessioners in specific locations only, therefore we may consider allowing ultra-quiet generators for some Concessionaires. We will contact you about your power needs.

**Health Dept.:** All concessioners must meet the requirements as set by the San Mateo County Health Department. This requires a fully screened booth plus a TFF Permit specifically for this Festival. The Health Department Fee is \$149.00 for this year's Festival. Agents of San Mateo County Health Department will be on site during the Festival. They can request removal of food concessionaires not in compliance with current Health Department regulations. Citations and fines may be issued by a Health Department Agent. ***Please check the San Mateo County Environmental Health web site prior to the festival for compliance.***

**Flooring & Washing Water:** Millbrae Chamber advises concessionaires of the City's concern about grease and cooking materials dripping and spilling on the streets, sidewalks, curbs and gutters causing damage. The Millbrae Chamber requires that all festival food preparation and food storage areas have a surface placed under them that protects the streets, curbs, gutters, and sidewalks from grease and other cooking materials. Suggested flooring will be tarps under plywood or cardboard. Flattened cardboard boxes will not suffice. Concessioner is responsible for providing water for washing of hands in each booth.

**Composting:** Please plan to offer biodegradable serving containers and utensils to your customers. Waste containers for composting food waste will be provided for Concessionaires in each food grouping area.

**Clean-up:** The concessioner is responsible for cleaning their area and properly disposing of trash, waste water and grease. The concessioner must provide two (2) trash receptacles for public use at the booth, and must keep the receptacles clean and emptied and usable at all times. The booth area must be left clean at the end of each day, including all spills and garbage. Non-compliance will result in loss of Cleaning Deposit.

**Insurance:** A Certificate of Liability Insurance, naming the Millbrae Chamber of Commerce and Team Pro Event Inc. as additional insureds, will be required from all accepted concessionaires.
